
### Queen Esther's Ministries Trinidad and Tobago



### QEMTT

Founded in 2020 Queen Esther's Ministries Trinidad and Tobago started with a team of 2 directors. Fast track to 4 years later and we have grown to be a team of close to 20 members including volunteers.

When QEMTT was founded by Mrs Ramkissoon, we started off doing just 10 hampers for our first hamper drive, to date we are now doing 100 hampers and more. # **Tobago Hamper of Hope**

Our Tobago Hamper of Hope distribution was conducted on 3rd to 6th January, 2024

Our hampers were packaged in Trinidad and then transported via boat to the island of Tobago which was then distributed to 18 families in need across various communities.

The hampers were given to single parent households who were struggling to put food on the table. Some of the families included a single mother who was sexually abused and became pregnant with no one to assist and she was struggling to survive giving the increase in cost of living, also included an elderly female living in an unbearable environment with one leg and no one to care for her full time.

Additionally single mothers who were coming out of abusive relationships and trying to make ends meet were provided with a hamper. Every family who received the hampers extended heartfelt gratitude for they said the food came just in time as they had nothing to eat.




"Eighteen (18) families were fortunate enough to received hampers in Tobago valued at 600TT"

## Feeding the Orphans

#### Partnering to feed the children at Hope Center



In May of 2024 Queen Esther's Ministries Trinidad and Tobago was honoured to be able to partner with a home for children who were abused, neglected and homeless to provide a meal, a drink and a desert for all the kids.

We spent an average of 100TT on a child providing them with a quality meal, a nice desert and a juice. President and Founder Mrs Esther Ramkissoon accompanied by another one of the directors personally visited the home delivered the meals to the kids and sat and talked with them as well as prayed with all the children.

The opportunity to do this was indeed a blessing as these children and those who are most in need of our love and care.









### **Easter Hamper of Hope Drive**

Since 2022 our president and founder of Queen Esther's Ministries, Mrs Esther Ramkissoon has asked persons instead of getting her a gift for her birthday to give towards QEMTT Easter Hamper of Hope Initiative. Each year single parents look forward to the assistance that they receive from this hamper drive.

This hamper drive not only allows single parents or guardians to benefit from it but also allows for this who are marginalised to be able to access some much needed assistance.

able to give to those less fortunate. Since she, herself was once in need and looked forward to the charitable acts from others to be able to get by Mrs Ramkissoon has started doing hampers through QEMTT to assist those who are considered vulnerable in society.

We at QEMTT understand that these times are difficult and that doing hampers only at Christmas time simply isn't enough. Our NGO also tries it's best to assist those in need outside of these initiatives as well by reaching out to sponsors and partners who are willing to assist as we know that there are many who are barely getting by in society.



# 1st Women's Empowerment Conference

### Hosted by **QEMTT**








For the very first time QEMTT was able to host our first ever Women's Empowerment conference for women all over Trinidad and Tobago. The purpose of the conference was to empower women to be better and do better in their lives not just for themselves but for their children. The conference was absolutely free and opened to 200 women who received a free meal and had the opportunity to access booths from Ministry of Social Development and Family Services, TTPS and also a medical speaker from the South West Regional Health Authority.

The more we assisted families in crisis the more we saw the need to invest in this conference to help transform the hearts and minds of the women we assist. We believe that if we can assist the women to be transformed that it will trickle down positively impacting the lives of the children in these families and hopefully making a life long impact to transforming communities and preventing children from becoming another statistic. We are hoping to be able to do this once a year and hosting it also for men.

# **Annual Back to School Initiative 2024**



This year in August of 2023, Queen Esther's Ministries was able to bless 150 kids with book bags filled with stationary items as well as a hamper of groceries to allow parents the opportunity to send their kids back to school on a full stomach.

For the second time also we were able to bless each child that was present for the back to school drive with a meal in the form of a box of KFC and a drink which was sponsored by Pastor Steven and Sister Nadia Naraine from Jesus First House of Worship, New York.

This initiative was held at the Lisas Garden Community Centre which was donated for us to use.

We were able to invite the MP for the area Mr. Rudranath Indarsingh who was also accompanied by the counsellor for Savonetta/Point Lisas Mr. Ramchand Rajbal Maraj. The event was hosted by award winning radio personality of the year from w107.1fm Karen Noel with special guest performances by gospel artiste Alyssa Jospeh.

This year's back to school initiative cost a little in excess of 150,000TT which was donated by various local and international sponsors who we are hoping will continue to partner with us to make a difference here in Trinidad and Tobago. Families and children from communities all across Trinidad attended the back to school drive which took place in the form of a service for the children and families. We were also honoured to have several of our sponsors in attendance as they were able to witness first hand where their investments are going and see the smiles of joy upon the faces of the children as they received a new book bag for heading back to school in August 2024.

# Queen Esther Ministries transforms struggles into support

chain throughout the year. Havini to overcome a tough inschalenging background, Rambissour used her experience to properher to start a non-governmental organisation (NGO) named Queen Esther's Ministries Trinidad and Tobago, which supports families in need.

Ramkissoon was quick to explain that the NGO was not named after her but instead inspired by Esther in the Bible.

The story of Esther is the one when she went before the king to get favour and when she found favour she was able to extend the favour she got onto the people so that is the gist behind it. I go to the company, I go to the sponsors and when I get the favour, they bless me because of my vision with the NGO, I am able to now extend it to other people."

extend it to other people." Explaining further how the idea of the NGO came about, she said, "What inspired me was how I grew up. I grew in an abusive home; mom was a single parent of 11 children and my dad growing up he was very abusive to her. He used to beat her, he had other women and other children."

#### Who feels it know it

Growing up with very little, Ramkissoon said her family relied heavily on charity to survive. Being the last of 11 children, she recalled her family living in small structure with dirt inside, before her mother was able to build a board house. But then tragedy struck the already struggling family when their home was destroyed hydre.

by fire. "We were literally homeless we spent the first night on the road.... and then everything from there when our home burn down we didn't have anything. So, everything we wore, everything we eat was basically what people gave to us, so it was charity that got us through," she recounted.

As a result of financial woes, Ramkissoon shared that she was unable to finish school. This, however, did not remain her fate as she took herself back to school doing two CXC subjects at a time before studying accounting. She said "from the age of 15 I started working and would work and do evening classes" She emphasised that all these ex-

She emphasised that all these experiences are "what birthed the NGO in my heart. When I was in a place to start it, I started it with me and two other directors. We didn't have any volunteers, I didn't even know how to go about getting sponsors and today some of the biggest companies in Trinidad and Tobago are faithful sponsors to the NGO," adding that several international companies also support the NGO.

She said the organisation started during the Covid-19 pandemic in 2020. "The first set of hampers we did was for families affected by Covid. Each hamper was a \$1,000 in value and we did just ten hampers. Moreover, she said, her biggest initiative under the NGO is the back-to-school drive supporting 100 children to be equipped for school. These included all stationery items needed for school, bookbags and a food hamper.

per. "So, today we continue it but we added to it so we now give every child who attends the back to school drive a meal which is sponsor and they get the bookbag with all the stationery items and the families still get the hamper of groceries and we do it like a red-carpet event for the children," she explained.

Noting her gratitude to all sponsors and partners, she said they are invited to the event as transparency is key to the organisation.

Apart from sponsorship, Ramkissoon said fundraisers are also a means to generating additional funds to support the NGO's initiatives.

According to Ramkissoon, a number of people from varying age groups volunteer with the NGO but the majority of her volunteers are young people and

#### university students.

In order to receive assistance, she said, an application is posted on its social media pages with application remaining open for a month.

During that time persons who see it online or know of people that are in need, they could give them the number and they can WhatsApp or call the number and the administrative assistant will call them back and get all their information."

According to Ramkissoon, a means test with detailed questions help to ensure that persons genuinely in need 1 get the oragnisation's assistance.

#### 200 applications received

She noted that the target was to assist 100 persons this Christmas but application exceeded the 200 therefore sifting through to assist those more in need becomes vital. "So, we try to prioritise single par-

"So, we try to prioritise single parents with multiple children and then it may have a single parent who is unemployed and we will give them priority," she said, adding then others are accommodated.

We have our seasonal drive which we will do every year for Easter, Back-to-School and for Christmas. Those are the three biggest drives but then in between we have families who apply and we help them. Those are the times all through the year, we won't advertise it, but we will help families if they reach out to us and thev are in need'said Ramkissoon. Described as a nobody before Ramkissoon said she is geteful God for blessings her that the can now be a blessing to many. Use amazed and humbled at how blessed lam to be a blessing to others,'she said.

What is important for Ramkissoon is ensuring that the hampers given have items that will go a long way, therefore giving a family of four five pounds of flour that will run out in a week's time is not effective frence, she makes a greater effor to not vide larger food items that has soot longevity. She noted that has soot longevity. She noted that he for per drive caters to families aucross the Trinidad and also in Tobago. She December 24, the NGO will host its annual Christmas hamper drive and treat to assist 100 families. We allow the families who are coming to collect the hamper to bring the kids to the treat...the treat is open to other children,"she said.

Children, She added applications are closed for this year. The 32-year-old wife and mother of one believes that order and structure in running her NGO is critical but more than that she pointed out the importance of not branding items given to families. She underscored that because she came from a difficult past of not having and being bullied in school because she was a recipient of charity, the backto-school programme is the nearest to her heart.





#### Mrs Esther Ramkissoon



QEMTT was founded on the book of Esther from the Bible. It is my strong conviction that my team and I have been "Called for such a time as this" Esther 4:14. I believe that they are many children and families right here in Trinidad and Tobago who are facing many struggles with providing the basic needs for their families such as food, clothing and shelter. I also believe that those we fail to educate we will eventually incarcerate thus contributing to the increase in the crime rate.

As such I am convinced that our methods of incorporating a spiritual approach with a physical approach is the best way to solving some of the many challenges that children and families are facing. While we are a Faith based organisation we work closely with children and families providing them with the physical resources needed to aid in quality education and a sound family life.

This year on the 22nd July, 2024 QEMTT will be celebrating our 5 year anniversary as a legally registered non profit organisation. While it is our futuristic plan to launch what is known as the "Dream Center" where children can access free after school assistance, we are also hoping to start the process by obtaining an official office space to be known as the base for operating QEMTT.

While we have been successfully operating without an office in times past as we continue to grow there is need for a physical office as we are now assisting a lot more families now in comparison to when we just started off and were only assisting 10 families at a time. Now we have hundreds of applications coming in and the need for an official office is greater now than before in order to be more effective in assisting those in need.

As we enter into 2025 it is my heartfelt encouragement to all to please be mindful of those around you, it could be in your neighbourhood or at work, there are people struggling in need all around us and as the cost of living goes up it is even harder for the average person to survive.
